The meeting was called to order by President Dan McMullen with the pledge to the flag. There were 10 members present. A **motion** by Dick Dotts and seconded by Art Rose was then passed "accepting the December 19, 2017 minutes." Dan reminded all present that the minutes were being taped.

#### Secretary's Report:

Shawn reviewed the Comparative Statement of Financial Position-2016 to 2017 and the Statement of Receipts and Expenditures- year ending December 31, 2017 with the members present. Also discussed was investing some of our funds in CD's.

A **motion** by Dane Kalwanaski and seconded by Ray Hollen was then passed "to accept the treasurer's report."

#### **Grant Committee:**

Dan submitted the Grant Application to Dominion's Peoples. He requested \$2,100.00 for lab expenses. We want to thank Dan (with Art's assistance) for taking care of this.

#### **Election Committee:**

The election was held for the one at-large Board seat. We want to congratulate Ray for his success in winning this position.

**Tech Committee:** The following Tech Report was presented by Art Rose-Chairman of the Tech Committee: **Tech Committee Report- January 16, 2018** 

<u>Klondike Project</u> The KL1 and KL2 outflows were sampled by Dan McMullen on 12/20. Lab analyses show good treatment at both sites. Plans for lowering the outflow at KL1 and installing the Fe-removal box were discussed with contractors.

<u>W Ferris Project</u> The sites were inspected and sampled by Dan McMullen on 12/10. Lab analyses indicate that all systems are releasing net alkaline water, though several effluents show appreciable Mn. A design for System 4 is being developed by Alder Run Engineering. A meeting to discuss the conceptual design is being scheduled with Michelle Merrow. Natcher Drilling was emailed about proceeding with drillholes to increase flow into System 3, but no reply has been received. Art Rose will phone him. Construction of inflow sample sites for System 3 was discussed with Slovikoski.

Little Laurel Sampling These sites were sampled on 12/20 by Shawn Simmers and Dan McMullen. The lab analyses show greatly decreased acidity as in recent samples.

Cooney discharge This site was sampled on 12/10. Lab results are similar to previous samples Gibson project The site was sampled on 12/17 by Shawn Simmers. Lab analyses show outflows are net alkaline but at system 2 the Fe and Mn are slightly elevated. Marking of a channel for 184 water remains to be done. We should contact the Game Commission on the channel for this flow. Also, balancing of flow into the 2 systems should be done with input from Michelle Merrow.

Beldin Project No activity. A quarterly report should be submitted by Art Rose.

Brubaker Project The upper Brubaker sites were not sampled during the month due to weather and vacations. Louisa Lytle and Art Rose plan to sample later this week.

Swank Project The inflow and outflow were sampled on 12/20 by Ray Hollen and others. The ouflow continues to show moderate but incomplete treatment. A downed tree blocking the road was removed.

<u>Ace Drilling</u> The treatment systems were inspected on 12/20 by Ray Hollen and others. The systems are treating well but several trees down across the road to system 26 required considerable walking. Art Rose will inquire of Malcolm Crittenden on the responsibility for removing these roadblocks.
